A Word from the Executive Director Susan Spring

The economic situation continues to be a challenge for families, businesses and nonprofit organizations in southeast Louisiana. In addition access to the Economic Stimulus funds through the American Recovery and Reinvestment Act has ended.

Fortunately the temporary funds for Early Head Start Expansion were made permanent which ensures that we are able to continue the expanded services to infants, toddlers and pregnant women.

In spite of the difficult economic situation across our state we are able to provide services with the help of many community partners. Examples include donations of Health Literacy books from North Oaks Hospital and Slidell Memorial Hospital. Collaborations with all school systems to provide therapy to children with special needs., and partnerships to serve children with behavior concerns. Students enrolled at Southeastern Louisiana University and Northshore Technical college who provide support for screenings, and also receive classroom training. A Sociology student, Sarah Scafidel provided hours of assistance on the community assessment. Walmart, Books-A-Million, and many local small businesses also provide donations of goods and services for parent activities and family needs. These agencies and others assist RCCDC in being a community based Head Start program.

Louisiana Legislature passes Act 3

The Louisiana Legislature passed one of Governor Jindal's education bills that will bring all publicly funded preschools under the authority of the oard of Elementary and Seondary Education. The rules and regulations will be developed in 2013 and piloted in a small group of programs across the state in 2013-14. The changes are designed to provide a consistent, quality preschool education across the state and ensure that children enter kindergarten ready to learn. Regina

School Readiness

Teaching Strategies' Creative Curriculum Gold Assessment is an evaluation of the 3 and 4 year old children enrolled during this program year. Teachers assessed each child through observing each child's behaviors. entered the observations into the CC Gold on line assessment and in-put checkpoints to indicate the level of mastery in the five major domains of "School Readiness". These checkpoints were finalized three times a year. The information was used to aggregate the information and show how each child. class.

and center, as well as the program as a whole, was progressing to meet the "Readiness Goals". The information was used to gain a better perspective on meeting the needs of the children in his/her classroom. This information was shared with the child's family during home visits and parentteacher conferences.

The educational program is a developmentally appropriate, research based curriculum designed to improve emergent literacy, numeracy, language, general cognitive and motor skills in an emotionally supportive learn-

ing environment.

RCCDC works closely with local school systems. We collaborated on several projects during the year. Children were prepared for kindergarten through classroom activities and field trips to the kindergarten which they planned to attend. Parents had opportunities to meet with school representatives and visit kindergarten classes with their child. Teachers also provided information on each child to the receiving school regarding the child's strengths and individual needs.

Health and Nutrition

Children who begin school with untreated concerns are likely to experience difficulty in their academic endeavors. For this reason, the Head Start program coordinates health-related services for children through speech screenings, hearing screenings, dental exams, immunizations and physicals. The goal of Head Start is to assist parents in connecting with a dental and a medical home for their children and for themselves to ensure continuous health care. By the end of the year almost every enrolled child leaves Head Start connected to a medical home and enrolled in a health care insurance program.

Nutrition

RCCDC centers participate in the "I'm Moving, I'm Learning" Project which seeks to add physical movement to the child's day at school and improve healthy food choices at school and for life. Meals are provided each day through the CACFP program.





Disabilities and Mental Health

DISABILITIES

Head Start requires that 10% of the funded slots be available to children with diagnosed disabilities. Of the total number of children served by RCCC, 20% had a Diagnosed Disability.

The disabilities included Speech and Language Delay, Autism, Hearing Impairment, Down Syndrome, Cerebral Palsy, and Health Impairment.

RCCDC has collaborative agreements with the Local Education Agencies, EarlySteps, and physicians to meet the needs of each child.

Children receive speech, language, and developmental screenings at the time of enrollment.

MENTAL HEALTH

Mental health support and services continues to be an area of critical need among many families located in the southern region of Louisiana. Many of the children are dealing with the absence of one or both parents due to incarceration, death, deployment in the military, separation of the parents or mental health issues of the parents. Many of the children are also experiencing the effects of child abuse, poverty, and/or exposure to substance abuse. The children are not emotionally prepared to cope with these situations. When a child or parent has been identified as being in need of mental health services, a referral is completed for the parent and/or child, as appropriate. RCCDC provided 58 families with mental health services. The services were provided to the children and/ or the children's parents. The sessions were conducted at the children's Head Start Center by a licensed mental health professional.

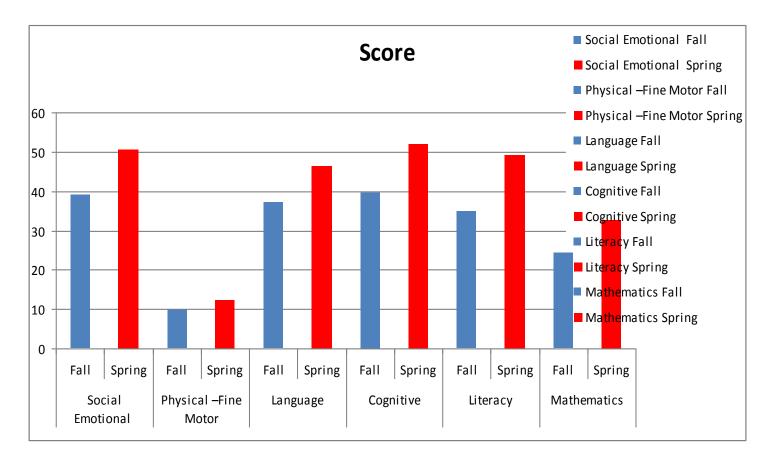
Two additional benefits from hiring Cecilia include her being bilingual since she speaks the language of her
